**The Corporation of The City of North Bay  
By-Law No. 2022-78**

**Being a By-Law to Appoint a Deputy Mayor  
and to Repeal By-Law No. 2018-71**

**Whereas** Section 242 of the *Municipal Act, 2001* as amended, provides that a municipality may appoint a member of the Council to act in the place of the head of council and to preside at meeting when the head of council is absent or refuses to act or the office is vacant;

**And Whereas** The Corporation of the City of North Bay's Procedural By-Law No. 2019-80 provides that the Councillor who placed first in the municipal election be appointed Deputy Mayor for the term of Council;

**And Whereas** Councillor Margaret Horsfield finished in first place in the October 24, 2022 municipal elections;

**Now Therefore** The Council of The Corporation of the City of North Bay Hereby Enacts as Follows:

1. That Margaret Horsfield be appointed as Deputy Mayor for The Corporation of the City of North Bay for the term of Council effective November 15, 2022.
  
2. That By-Law No. 2018-71 is hereby repealed.

**The Corporation of The City of North Bay**

**By-Law No. 2022-82**

**Being a By-Law to Confirm Proceedings  
of the Inaugural Meeting of Council Held on  
November 15, 2022**

**Whereas** the *Municipal Act, R.S.O. 2001*, Chapter 25, (the "Act") Section 5(1), provides that the powers of a municipal corporation shall be exercised by Council;

**And Whereas** Section 5 (3) of the Act provides a municipal power, including a municipality's capacity, rights, powers and privileges under section 9 of the Act, shall be exercised by by-law unless the municipality is specifically authorized to do otherwise and any of the matters shall be implemented by the exercise of the natural person powers;

**And Whereas** in many cases action which is taken or authorized to be taken by Council does not lend itself to the passage of an individual by-law;

**Now Therefore, The Council of The Corporation of The City of North Bay Hereby Enacts As Follows:**

1. That the actions of the Council of The Corporation of the City of North Bay at its meeting held on November 15, 2022 in respect of each motion, resolution and other action passed and taken by the Council at its said Meeting is, except where the prior approval of the Local Planning Appeal Tribunal or other authority is by law required, hereby adopted, ratified and confirmed.
2. That where no individual by-law has been passed with respect to the taking of any action authorized in or by the Council mentioned in Section 1 hereof or with respect to the exercise of any powers of the Council, then this by-law shall be deemed for all purposes to be the by-law required for approving and authorizing the taking of any action authorized therein or thereby required for the exercise of any powers therein by Council.
3. That the Mayor and the proper officers of The Corporation of the City of North Bay are hereby authorized and directed to do all things necessary to give effect to the said actions or to obtain approvals where required, and to execute all documents as may be necessary and directed to affix the corporate seal to all such documents as required.
