- 1. That By-law No. 122-98 be amended by deleting Schedule "A" thereto and inserting in lieu thereof Schedule "A" attached hereto and forming part of this by-law.
- 2. That Clause No. 1 of By-law No. 122-98 be amended by deleting the figure \$100,000.00 in the last line thereof and inserting in lieu thereof the figure \$140,000.00.
