THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 128-79

BEING A BY-LAW TO PROVIDE THE SUM OF \$45,000 TO DEFRAY THE COST OF IMPROVEMENTS TO THE LEE PARK SOCCER FIELD IN THE CITY OF NORTH BAY.

WHEREAS the Municipal Act R.S.O. 1970 Chapter 284, Section 352, paragraph 74, provides for the work herein described;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The installation of lighting at the Lee Park Soccer Field including concrete poles, installation, metal halied lamps and fixtures at a total estimated cost of \$45,000 is hereby authorized.
- of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes, temporary advances of money to meet the cost of the aforesaid expenditures pending the issue and sale of debentures hereinafter referred to, but in no event shall the aggregate of such borrowing exceed the amount limited in this by-law.
- Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of the Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
- The debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as Council may determine and shall be made payable within 15 years on the installment plan and shall be a charge against all rateable property in the City of North Bay.
- This by-law shall not become effective until approval has been received from the Ontario Municipal Board pursuant to the Ontario Municipal Board Act, R.S.O. 1970, Chapter 323, Section 64 (1).


