## BY-LAW NO. 2004-61

## BEING A BY-LAW TO AUTHORIZE THE 2004 CAPITAL ALLOCATION TO THE NORTH BAY PUBLIC LIBRARY

WHEREAS the *Municipal Act*, 2001 (S.O. 2001, c-25), Section 326 authorizes the Council to pass a by-law for the purposes therein stated;

AND WHEREAS the *Municipal Act*, 2001 (S.O. 2001, c-25), Section 401 authorizes the Council to pass a by-law for the purposes herein stated;

AND WHEREAS the Council passed Resolution 2004-199 at its meeting held March 22, 2004, authorizing the 2004 capital allocation to the North Bay Public Library, being 2004 Capital Budget Project No. 63, of \$100,000.00;

## NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS;

1. That the expenditure of \$100,000.00 for the following projects for the North Bay Public Library be hereby authorized for:

Renovations to Children's Department	
and Foyer	\$ 27,000.00
Fire Alarm Upgrade – third and final	
stage of final upgrade	7,000.00
Replacement of 14 computers	32,200.00
Replacement of Adult Department magazine	
area furniture	5,000.00
Upgrades to Handicapped Washroom	5,000.00
Bricking of pathway along Worthington	
Street East to Sherbrooke; installation	
of additional bike stand	4,000.00
Preliminary engineering and planning for	
Replacement of boiler heating system	
and design of library extension	9,800.00
Financing and Contingency Costs	<u>10,000.00</u>
Net Amount to be Debentured	\$ 100,000.00

- 2. That the Treasurer of the City of North Bay is hereby authorized to borrow from time to time from any bank or person by way of promissory note or notes temporary advances of money to meet the cost of work as aforesaid pending the completion thereof and pending the issue and sale of the debentures hereinafter referred to but in no event shall the aggregate of such borrowings exceed the amount of \$100,000.00 limited in this by-law.
- 3. Any promissory note or notes issued pursuant to paragraph 2 hereof shall be sealed with the seal of The Corporation of the City of North Bay and signed by the Mayor or Deputy Mayor and the Treasurer of the City of North Bay.
- 4. That the debentures to be issued when the work is completed to pay for the cost of such work shall bear interest at such rate as the Council may determine and shall be made payable within fifteen (15) years.
