

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 27-89

BEING A BY-LAW TO AMEND TRAFFIC BY-LAW NO. 2-82 (SCHEDULE 8 - DESIGNATED THROUGH STREETS, SCHEDULE 17 - TRAFFIC CONTROL SIGNALS, SCHEDULE 2 - NO PARKING ANYTIME, SCHEDULE 13 - SPEED LIMITS).

WHEREAS the Municipal Act, R.S.O. 1980, Chapter 302, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

AND WHEREAS the Highway Traffic Act, R.S.O. 1980, Chapter 198, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule 8 to Traffic By-law No. 2-82 is hereby amended by adding the following:

SECTION P:

<u>Road:</u>	<u>From:</u>	<u>To:</u>
12. Pinewood Park Drive	Lakeshore Dr.	Southerly to City Limits.

2. That Schedule 17 to Traffic By-law No. 2-82 is hereby amended by adding the following:

Intersection:

29. Pinewood Park Drive at Lakeshore Drive

3. That Schedule 2 to Traffic By-law No. 2-82 is hereby amended by adding the following:

SECTION P:

<u>Road:</u>	<u>Side:</u>	<u>Between:</u>
4. Pinewood Park Drive	Both	Lakeshore Drive and a point 150 metres north of Decaire Road.


4. That Schedule 13A to Traffic By-law No. 2-82 is hereby amended by adding the following:

<u>Road:</u>	<u>Km./Hour:</u>	<u>Between:</u>
9. Pinewood Park Dr.	70 km/hr.	Lakeshore Drive and a point 125 metres south of Decaire Road.
10. Pinewood Park Dr.	80 km/hr.	From a point 125 metres south of Decaire Road to the southerly City limit.


READ A FIRST TIME IN OPEN COUNCIL THE 30TH DAY OF JANUARY, 1989.
