BY-LAW NUMBER 539

BEING a By-law to appoint a Fire Chief, Regular Firemen, and Volunteers for the Fire Department of the Town of North Bay, and defining their duties and powers.

WHEREAS it is deemed advisable by the Municipal Corporation of the Town of North Bay to employ two officers to be known as a Fire Chief and Assistant Chief, and three regular men also one extra man for eight months yearly, and one volunteer, and to define their duties.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED BY THE MUNICIPAL COUNCIL OF THE TOWN OF NORTH BAY AS FOLLOWS:-

1. That J. O. REDDEN be appointed as FIRE CHIEF, and that his duties and powers be as follows.

1. He will report and receive instructions from the Fire Water and Light Committee, and will engage and have charge of all men in the Department, and will have charge of all material, horses, and appliances in connection with the Fire Department, including Fire Station, Stable and rooms occupied by the Department. He shall have the power to suspend for cause, any member of his force, and immediately report same to the Fire, Water & Light Committee, for action.

2. He will take charge at all fires, and will see that the men under his charge are capable and attend promptly to their several duties, at all times, and that they keep themselves dressed neat and tidy when not at fires, or doing rough work in the Fire Station.

3. He will be expected to refrain from unnecessary noise, and rough or profane language, either when at fires, or at the Fire Station, and will see that the men under his charge adhere strictly to this rule.

4. He will submit monthly reports of fires giving dates, time, and length of time working at fire, and an estimate of the damage.

The above report to be forwarded to the Council by the Fire

Water & Light Committee, at the first meeting of the Council in the following month.

5. The duties of the Assistant Chief will be to work in conjunction with the Fire Chief, and to act under his instructions and will have full charge during the absence of the Chief.

The Fire Chief will be paid \$1000.00 for the first year, \$1100.00 for the second year, and \$1200.00 the third and ensuing years.

The Assistant Chief will be paid \$1020.00 per annum.

The regular men will be paid \$960.00 per annum.

The extra man will be paid \$80.00 per month.

The Volunteer will be paid \$144.00 each year.

All men will be paid twice monthly.

All regular men will be supplied with one full uniform, and a summer and winter cap each year.

The Chief, Assistant Chief, and all regular men will sleep in the Fire Station, and will have one day of twenty-four hours off duty per week, and leave of absence 10 days annually; but in case of fires during the day they are off duty, they will be expected to report for duty.

By-law No. 507 is hereby repealed.
