> BEING A BY-LAW TO AMEND BY-LAW NO 2001-71 BEING A BY-LAW TO AUTHORIZE CHANGES TO USER FEE SCHEDULES FOR VARIOUS DEPARTMENTS AT CITY HALL (RECREATION \& LEISURE SERVICES)

WHEREAS Section 220.1 of the Municipal Act authorizes the Council and Local Boards to pass bylaws imposing fees or charges for services or activities provided or done by or on behalf of the municipality or the Local Board and for the use of the property;

AND WHEREAS the Council of the City of North Bay has deemed it desirable to amend Bylaw No. 2001-71 to include fees for athletic fields and facilities and passed Resolution No. 2002-383 at its meeting held July 8,2002 to include a schedule for athletic fields and facilities;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule " J " attached hereto and forming part of this by-law be hereby added to User Fee By-law No. 2001-71.
