WHEREAS Section 220.1 of the Municipal Act authorizes the Council and Local Boards to **pass** bylaws imposing fees or charges for services or activities provided or done by or on behalf of the municipality or the Local Board and for the use of the property;

AND WHEREAS the Council of the City of North Bay has deemed it desirable to amend By-law No. 2001-71 to include fees for athletic fields and facilities and passed Resolution No. 2002-383 at its meeting held July 8,2002 to include a schedule for athletic fields and facilities;

NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Schedule "J" attached hereto and forming part of this by-law be hereby added to User Fee By-law No. 2001-71.
- 2. That this by-law take effect December 31,2002.
