Further Be It Resolved that this motion encourage the Provincial Government to take additional steps to protect teens aged 16 and 17 years, by considering raising the age of child protection from age 16 to 18; as currently teens of those ages are not able to be taken from perilous situations.

Further Be It Resolved that the Council of the City of North Bay send a letter and copy of this motion to Premier Kathleen Wynne, Yasir Naqvi, Attorney General, Bill 158's originator MPP Laurie Scott of Haliburton-Kawartha Lakes-Brock, Nipissing MPP Victor Fedeli, the Leaders of the Opposition, the Standing Committee of Justice Policy, as well as the Federation of Northern Ontario Municipality and the Association of Municipalities Ontario.

Whereas Conservation Authorities are critical partners for
Municipalities and the Province in meeting the social, economic and
environmental prosperity of our communities in a way that balances
human needs with the needs of the natural environment;

And Whereas the Municipality of North Bay and the nine other member municipalities rely on the North Bay-Mattawa Conservation Authority to provide technical advice, plan review expertise, municipal drinking water source protection, flood warning, stewardship, watershed management services and development proposal comments;

And Whereas to support a collaborative, complementary partnership between municipalities, Conservation Authorities and the Province, it is crucial that Conservation Authorities have the means, capacity and resources to be proactive in integrated watershed management;

Therefore Be It Resolved that the Municipality of North Bay calls upon the Province to consider the following in response to *Conservation Authorities (CA) Act: Conserving Our Future, Proposed Priorities for Renewal*:

- Integrated Watershed Management (IWM) is an approach that
 manages the impacts of human activities on important natural
 resources in order to protect them and ensure their sustainability.
 The IWM mandate of Conservation Authorities should be
 acknowledged as a priority in the CA Act Review and its role as a
 delivery agent for IWM be incorporated as a priority in new
 legislation, supported by policy and adequate resourcing;
- 2. Conservation Authorities' mandate to "undertake watershed-based programs and activities deemed to be vital to the health of their watersheds and residents' as stipulated in the CA Act needs to be preserved with a recognition that Conservation Authorities' "core mandate" extends beyond natural hazards;
- 3. Conservation Authorities need to work at an 'inter-ministerial' table rather than just one ministry. This recognizes that Conservation Authorities' programs and services benefit many ministries and help to address multiple provincial priorities. Ongoing sustainable funding needs to come from multiple ministries;

4. Multiple options such as shared Conservation Authorities services or Conservation Authorities restructuring should be looked at in order to improve the capacity and consistency of Conservation Authorities. Varying financial capacity among Conservation Authorities impacts the programs and services that are available on a province-wide basis; and further

5. That the Municipality of North Bay endorses the response of Conservation Ontario and the North Bay-Mattawa Conservation Authority to the proposed priorities.
