THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY, PURSUANT TO THE MUNICIPAL ACT, R.S.O. 1960, CHAPTER 249 SECTION 377 PARA-GRAPHS 67 AND 68, HEREBY ENACTS AS FOLLOWS:

- 1. THAT capital funds in the sum of \$60,000.00 be provided during the year 1969 for the purpose of acquiring by purchase the east part of Lot 129 on the south side of McIntyre Street West as shown on registered Plan No. 10 for the City of North Bay to be placed under the management and control of the North Bay Parking Authority.
- 2. THAT the Treasurer of The Corporation of the City of North Bay agree with any bank to borrow the aforesaid sum of \$60,000.00 by way of a term promissory note for a period of not more than five years bearing interest at the rate of not more than seven and one quarter per cent $(7\frac{1}{4}\%)$ per annum.
- 3. THIS BY-LAW shall take effect upon the final passing thereof and upon receiving the approval of the Ontario Municipal Board.






