THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 72 -86

BEING A BY-LAW TO AMEND BY-LAW 40-70, AS AMENDED, BEING A BY-LAW TO APPOINT A LOTTERY LICENCING OFFICER AND TO PROVIDE FOR A PROCEDURE AND OTHER REQUIREMENTS IN RESPECT OF THE LICENCING OF LOTTERIES FOR CHARITABLE AND RELIGIOUS PURPOSES.

WHEREAS the Council of the City of North Bay deems it desirable to increase the fees charged for lottery licencing to counter the cost of preparing and issuing licences and any additional costs relative to supervision and control.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Section 5 of By-law No. 40-70 be amended by deleting Section
 - 5 from the By-law and inserting in lieu thereof the following Section 5:
 - 5. The Corporation shall issue licences to applicants for permission to manage and conduct lotteries pursuant to this by-law, in accordance with the following schedule of fees:

1. Bingo Lotteries:

- (a) That the aggregate amount of all prizes offered or given at any one bingo event shall not exceed \$2,500.
- (b) Where the total value of prizes to be awarded within each operation does not exceed \$500 - \$5.00 per licence; provided that where such total value does not exceed \$25.00, a fee of \$2.00 shall be charged.
- (c) Where the total value of prizes to be awarded within each operation exceeds \$500 but is not more than \$2,500 a fee of 3% of the total value of prizes as set out in the application.
- (d) A licence for a series of bingo lotteries shall be issued on the same basis as (a) or (b) above

2. Raffle Lotteries:

An amount equal to 3% of the estimated total value of prizes to be awarded shall be applied.

3. Bazaars - \$5.00

All applications for the licencing of lotteries in excess of the monetary limits set out herein shall, subject to prior approval and recommendation of the Council of the Corporation, be referred to the Ministry of Consumer and Commercial Relations of the Province of Ontario.

2. That this by-law shall come into force and effect May 1,, 1986.
