AND FURTHER THAT a copy of this resolution asking for support be forwarded to the leaders of the Provincial opposition; Federation of Northern Ontario Municipalities; Association of Municipalities of Ontario; Federation of Canadian Municipalities; and all Members of Provincial Parliament.
