## BY-LAW NO. 2295

Being a By-law ratifying and confirming the purchase from The Hydro Electric Power Commission of Ontario the land hereinafter more particularly described for the sum of \$2,587.00 and the acquisition and purchase of the water and sewer service pipes in, on or under the said land for the price or sum of \$1,353.30;

And being a By-law assuming the said landsfor the purpose of a public highway.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That the acquisition and purchase from The Hydro-Electric Power Commission of Ontario of the land hereinafter described for the price or sum of \$2,587.00 and the acquisition and purchase from The Hydro-Electric Power Commission of Ontario of the water and sewer service pipes in, on or under the said land at the price or sum of \$1,353.30 be and they are hereby ratified, approved and confirmed.

2. That the aforesaid land, hereinafter more particularly described, be and it is hereby assumed by The Corporation of the City of North Bay for the purposes of a public highway.
