BY-LAW NUMBER 857. Amusled law 80

BEING A BY/LAW to authorize the Tax Commissioner to receive advance payments of taxes and allow a discount thereon.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

The Tax Commissioner is hereby authorized to receive up to April 30th in any year payments on account of the taxes for that year in advance of the day that may be fixed by By-Law for the payment of any instalment of such taxes and to allow a discount on any taxes/paid in advance at the rate of Five per cent per annum, according to the schedule hereto attached and marked "A" and which forms part of this By-Law, notwithstanding that the taxes for any such year, has not been levied, or that the Assessment Roll on which the taxes are to be fixed and levied has not been adopted by the Council, when such advance payment is made.

Any Tax payer shall not pay in advance a sum greater than the amount of his previous years taxes, and in any event the said payment made by any such tax

payer shall not be less than Five Dollars and not more 00.801 03.3
