## BY-LAW NO. 1161

BEING A BY-LAW to regulate the closing of Barber Shops in the City of North Bay.

BE IT ENACTED AND IT IS THEREFORE HEREBY ENACTED BY THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY AS FOLLOWS:-

- 1. That By-Law Number 1126 be, and the same is hereby repealed.
- 2. That Barbers' Shops shall mean and include hair-dressing parlors and other places where hair is dressed, served or washed or other work done on human hair.
- 3. From and after the date of the passing of this By-Law all Barbers' Shops within the limits of the City of North Bay, shall be closed as follows:-
- (a) Wednesday afternoons from twelve-thirty P.M. to five A.M. in the forenoon of the next following day on which such business can be legally carried on during the months of January, February, March, April, May, June, July, August, September and October of each year.
- (b) During the entire day of all legal holidays whether Dominion, Civic or otherwise.
- (c) Mondays, Wednesdays (except as provided in subsection "A") and Fridays of each week throughout the year at seven P.M. until five A.M. of the next following day on which such business can be legally carried on.
- (d) Tuesdays and Thursdays of each week, throughout the year, at seven P.M. until the hour of five A.M. on the next following day on which such business can be legally carried on.
- (e) Saturday night of each week at ten P.M. until five A.M. on the next following day on which such business can be legally carried on.
- 4. NOTWITHSTANDING anything contained in the preceding paragraph and sub-section thereof all Barbers' Shops within the limits of the said City may remain open until the hour of ten O'clock of any evening preceding (a) any legal holiday as outlined in paragraph (b) of Section 2; (b) the three evenings immediately preceding Christmas day.
- 5. When in any week during the year a legal holiday is observed which falls on any day other than Wednesday all Barbers' Shops within the City may remain open non the said Wednesday for the whole of the said day.
- 6. NO CUSTOMER shall be admitted in any Barber Shop within the limits of the said City to be served between the hours hereinbefore specified, and the owner, occupier or other person in charge of each such shop shall close, and keep such shop closed within the hours hereinbefore provided.
- 7. ANY PERSON convicted of a breach of any of the provisions of this By-Law shall forfeit and pay, at the discretion of the convicting Magistrate, a penalty not exceeding, exclusive of costs, the sum of FIFTY DOLLARS (\$50.00) for each offence, and in default of payment of the said penalty and costs forthwith the said penalty and costs, or costs only, may be levied by distress and sale of the goods and chattels of the offender, and in case of there being no distress found out of which such penalty can be levied, the convicting Magis trate may commit the offender to the Common Gaol of the City of

North Bay with or without hard labour, for any period not exceeding six calendar months, unless the said penalty and costs, if any, including the costs of the said distress and of the committal and conveyance of the offender to the said Gaol, are sooner paid.

8. THIS BY-LAW is passed on accordance with the provisions of the Revised Statutes of Ontario, 1927, Chapter 275 and amendments thereto and pursuant to the Petition presented in accordance therewith.

THIS BY-LAW shall take effect immediately after the passing thereof.
