BY-LAW NO. 122-71

BEING A BY-LAW TO APPOINT POLLING PLACES, AND THE DEPUTY RETURNING OFFICERS AND POLL CLERKS FOR PURPOSES OF THE GENERAL MUNICIPAL ELECTION, 1971.
