WHEREAS Councils of Municipalities may pass by-laws pursuant to Section 27 of the Public Utilities Act, R.S.O. 1970 Chapter 390 designating the places where water accounts may be payable;

AND WHEREAS the Corporation of the City of North Bay deems it advisable;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- (1) That the Treasurer be directed to authorize the banks and trust company listed in Schedule "A" attached hereto to receive payment for water accounts on behalf of the Corporation of the City of North Bay.
- (2) That the Treasurer be directed to authorize the banks and trust company listed in Schedule "A" attached hereto to stamp as paid all accounts for water for which payment is received in full and to transfer such payment and duplicate stamped original of such account to the Royal Bank of Canada, Main Street Branch, North Bay, for credit to the Corporation of the City of North Bay.
