BY-LAW NO. 1999-31

BEING A BY-LAW TO AUTHORIZE THE EXECUTION OF A MEMORANDUM OF AGREEMENT AND A LOCAL SIDE AGREEMENT DATED THE 4TH DAY OF MARCH, 1999 AND AN INTERMUNICIPAL SERVICE AGREEMENT RELATING TO THE TRANSFER OF THE PROVINCIAL OFFENCES ADMINISTRATION CENTRE

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That The Corporation of the City of North Bay enter into a Memorandum of Agreement and a Local Side Agreement with Her Majesty the Queen in Right of Ontario, as represented by the Attorney General, dated the 4th day of March, 1999 relating to the transfer of the Provincial Offences Administration Centre.
- 2. That The Corporation of the City of North Bay enter into an Intermunicipal Service Agreement with the District of Nipissing Municipal Partners, District of Parry Sound Municipal Partners, the District of Sudbury Municipal Partners and the Nipissing Band of Ojibways dated as of the 15th day of March, 1999 relating to the Court Administration and Court Support functions under the *Provincial Offences Act* and the prosecution of matters commenced under Parts I and III of the Act.
- 3. That the Mayor and Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain Memorandum of Agreement and Local Side Agreement between The Corporation of the City of North Bay and Her Majesty the Queen in Right of Ontario, as represented by the Attorney General, and to affix thereto the corporate seal, and to execute such further and other documents as may be reasonably required to give effect to the transaction.
- 4. That the Mayor and Clerk of The Corporation of the City of North Bay are hereby authorized to execute that certain Intermunicipal Service Agreement between The Corporation of the City of North Bay and the District of Nipissing Municipal Partners, District of Parry Sound Municipal Partners, the District of Sudbury Municipal Partners and the Nipissing Band of Ojibways, and to affix thereto the corporate seal, and to execute such further and other documents as may be reasonably required to give effect to the transaction.
