

A BY-LAW TO PROVIDE FOR THE 19 67 EXPENDITURES ON ROADS OR STREETS
IN THE CITY ~~XXXXXXXXXXXXXX~~ OF NORTH BAY IN THE
~~XXXXXX~~ OF NIPISSING
~~DISTRICT~~

WHEREAS under The Highway Improvement Act a by-law to provide for expenditure on roads or streets may be submitted annually to the Minister of Highways for approval.

THEREFORE the Council of the Corporation of the said City/~~XXXXXXXXXXXXXX~~ enacts as follows: -

(1) The sum of \$ 241,600.00 is hereby estimated as the expenditure upon the construction and maintenance of the roads and bridges under its jurisdiction during the year 19 67 as follows:-

(2) The said monies shall be expended on work performed in accordance with The Highway Improvement Act.

(3) The clerk shall transmit triplicate copies of this by-law to the district office of the Department of Highways Ontario, not later than March 31st, of the said year.

(4) The approval of the Ontario Municipal Board shall be obtained before any expenditure is authorized or work commenced which will be financed by the issue of debentures or monies raised in a subsequent year.

of the Board made on the 13th day of June, 1962, and entered



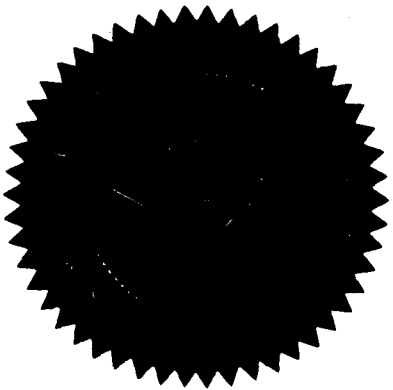

in order book No.E 32 at folio 213 on the 15th day of June, 1962, and for such purpose may pass all requisite by-laws, including by-laws providing for the issue of debentures in a principal amount not exceeding \$96,000.00 repayable within the term prescribed in the said previous order, and may borrow money to the extent sufficient to provide an amount not exceeding \$96,000.00 therefor, provided that the said Corporation may borrow the whole or any part of the said sum of \$96,000.00 as required pending receipt of subsidies and the sale of debentures, or of moneys to be received from any other source.
