

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 2002-43**

**BEING A BEING TO AMEND TRAFFIC BY-LAW NO.  
131-93 – SECTION 35(2) ADMINISTRATION; SECTION 12 (NO  
PARKING ANYTIME – WINTER MONTHS) AND  
SCHEDULE 2 (NO PARKING AREAS AT ANY TIME)**

**WHEREAS** the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass by-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the Highway Traffic Act, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass by-laws regulating traffic on highways;

**AND WHEREAS** it is deemed expedient to regulate or prohibit certain traffic and to regulate or prohibit certain parking within the limits of the City of North Bay;

**AND WHEREAS** the Council passed Resolution Nos. 2002-158 and 2002-157 at its meeting held March 25,2002 to amend Traffic By-law No. 131-93;

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Traffic By-law No. 131-93 be amended by deleting Section 35(2) therefrom and inserting in lieu thereof the following Section 35(2):

35. Administration

- (2) The Managing Director of Public Works and Services is hereby authorized to place and maintain temporary traffic signs for the purpose of regulating or prohibiting traffic where highway construction, repair, painting, community events or other emergency occurs.

2. That Section 12 – “No Parking Areas Anytime – Winter Months” be amended by adding the following thereto:

- (2) The Managing Director of Public Works and Services is hereby authorized to erect temporary parking restriction signs as required under his/her discretion.

3. That Schedule 2 to Traffic By-law No. 131-93 be amended by adding the following:


4. This by-law comes into force and effect upon passing.
