BEING A BY-LAW of the Municipal Corporation of the City of North Bay to close part of Metcalfe Street and various parts of lanes as shown in Schedule affixed to this By-Law.

WHEREAS the Municipal Corporation of the City of North Bay under agreement with the Canadian National Railway for exchange of certain lands are required under said agreement to close part of Metcalfe Street and certain lanes as described in Schedule A attached hereto and forming part of this By-Law.

THEREFORE UNDER AND BY VIRTUE OF THE AUTHORITY VESTED IN THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY BY THE MUNICIPAL ACT, BEING R. S. O. 1937, CHAPTER 266, THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

1. That that part of Metcalfe Street and those certain parts of lanes described in Schedule A affixed hereto and forming part of this By-Law be and the same are hereby closed and stopped up.

2. That forthwith upon this By-Law taking effect the Council of the Municipal Corporation of the City of North Bay shall convey the said part of Metcalfe Street and certain parts of lanes as closed and stopped up in Schedule A affixed hereto to the Canadian National Railway as per Agreement.

3. That the Council of the Municipal Corporation of the City of North Bay shall hear in person or by his or her solicitor, Counsel or agent, any person who claims that his or her lands will be prejudicially affected by this By-Law, and who applies to be heard.

4. That this By-Law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.
