AND WHEREAS the Nipissing First Nation has long disputed the circumstances under which these surrenders where obtained;

AND WHEREAS a substantial portion of these lands were sold to private interests while 58% of the land remained unsold;

AND WHEREAS the Nipissing First Nation, the Government of Canada and the Government of Ontario successfully concluded a specific claim negotiation in 1995 to enable the return of these unsold surrendered lands to the Nipissing First Nation;

AND WHEREAS the specific claim has not been fully implemented due to delays in obtaining a Federal Order-in-Council from the Government of Canada that would fully restore the lands to the Nipissing First Nation;

AND WHEREAS this delay has cost the Nipissing First Nation a substantial amount of revenue which could have been realized in the form of grants in lieu of taxes;

AND WHEREAS members of North Bay City Council and City staff attended educational presentations offered by the Nipissing First Nation as part of the Aboriginal National Day of Action on June 29, 2007;

AND WHEREAS one of several serious issues raised which negatively affects our neighbour, the Nipissing First Nation, is the unreasonable delay in returning the Nipissing First Nation's Unsold Surrendered Lands;

NOW THEREFORE BE IT RESOLVED that the Council of the City of North Bay hereby indicates its support for the return of the Nipissing First Nation's lands to the west of the City of North Bay in Pedley, Beaucage and Commanda Townships and calls on the Government of Canada to meet its obligations in a timely manner and provide the Order-in-Council to the Nipissing First Nation.
