## BY-LAW NO. 995

BEING A BY-LAW of the Municipal Corporation of the City of North Bay to close a certain lane within the said City of North Bay.

WHEREAS the Municipal Council of the Corporation of the City of North Bay has been requested, and upon consideration, deems it advisable to close the lane between Lots Nos. 144, 145 146, 147 and 148 on the East Side of Victoria Street and Lots Nos. 214, 215, 216, 217 and 218 on the West Side of Princess Street respectively, and to convey the said lane upon its being closed up to the Board of Trustees of the North Bay Public Schools.

THEREFORE, under and by virtue of the authority vested in the Municipal Council of the Corporation of the City of North Bay by the Municipal Act being R.S.O. 1927, Chapter 233, the MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

- 1. THAT the lane between Lots Nos. 144, 145, 146, 147 and 148 on the East Side of Victoria Street and Lots Nos. 214, 215 216, 217 and 218 on the West Side of Princess Street respectively as the said lanes are more particularly described in Schedule "A" which is attached hereto and forms a part of this By-Law and as the same are shown on a plan prepared by John H. Shaw, 0. L. S., and registered on the 11th day of January, A. D. 1905, be and the same are hereby closed and stopped up.
- 2. THAT forthwith upon this By-Law taking effect the Municipal Council of the Corporation of the City of North Bay shall convey to the Board of Trustees of the North Bay Public Schools the lane closed and stopped up under the provisions of Section 1.
- 3. THAT the Municipal Council of the Corporation of the City of North Bay shall hear in person or by his or her counsel, solicitor or agent any person who claims that his or her lands will be prejudicially affected by this By-Law and who applies to be heard.
- 4. THAT this By-Law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.

## SCHEDULE "A"

This is Schedule "A" referred to in By-Law No. 995 attached hereto.

Description of lane referred to in Section 1 of By-Law No. 995.

All and singular that certain parcel or tract of land and premises situate, lying and being in the City of North Bay, in the District of Nipissing and Province of Ontario, containing 1/10 of an acre be the same more or less, being composed of a lane between lots 144, 145, 146, 147 and 148 and lots 214, 215 216, 217 and 218 as the said lots and lane are laid out and shown on a plan of subdivision prepared by John H. Shaw, O.L.S., and registered in the Registry Office for the said District at North Bay, Ontario the 11th, January, 1905 and which said parcel may be more particularly described as follows:

commencing at the North-east of said lot 144 thence southerly along the easterly limit of said lots 144, 145, 146 147 and 148, three hundred and thirty feet (330') more or less to the south east angle of said lot 148, thence easterly in a straight line, fourteen feet (14') more or less to the south west angle of said lot 214, thence northerly along the westerly limit of said lots 214, 215, 216, 217 and 218 three hundred and thirty feet (330') more or less to the north west angle of said lot 218; thence westerly in a straight line fourteen feet (14') more or less to the said place of commencement.
