

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 49-72

BEING A BY-LAW AUTHORIZING THE EXECUTION OF THAT CERTAIN AGREEMENT DATED THE 1ST DAY OF MAY, 1972 BETWEEN JEAN-MARIE ST. GELAIS AND THE CORPORATION OF THE CITY OF NORTH BAY RELATING TO THE COLLECTION, REMOVAL AND DISPOSAL OF GARBAGE IN THE CITY OF NORTH BAY.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. THAT the Corporation of the City of North Bay do enter into that certain agreement dated the 1st day of May, 1972 between Jean-Marie St. Gelais and The Corporation of the City of North Bay relating to the collection, removal and disposal of garbage in the City of North Bay upon and subject to the terms and conditions set forth in the said agreement.
- 2. THAT the Mayor and Clerk be and they are hereby authorized and empowered to execute the aforesaid agreement dated the 1st day of May, 1972 on behalf of The Corporation of the City of North Bay and to affix thereto the Corporate Seal.

READ A SECOND TIME IN OPEN COUNCIL THIS 8TH DAY OF MAY, 1972.
READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 10TH DAY OF JULY , 1972.

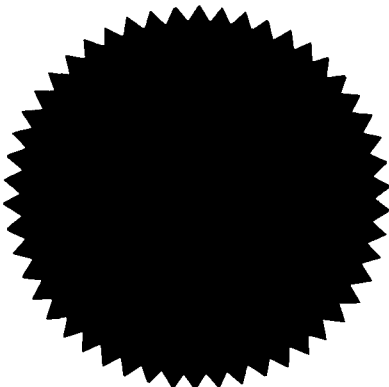
