<u>BEING</u> A BY-LAW of the Corporation of the City of North Bay to provide for the submission of certain By-Laws for the assent of qualified electors of the City of North Bay and to appoint a day on which to take a vote thereon and to name places where the votes are to be taken and to appoint Deputy Returning Officers to take a vote at every such place.

<u>WHEREAS</u> the Municipal Council of the Corporation of the City of North Bay deems it advisable to submit to the vote of electors of the Corporation qualified to vote on Money By-Laws the following proposed Money By-Laws.

(a) A By-Law to install a sewage disposal plant in the City of North Bay and to provide for the borrowing of Six Hundred and Fifty Thousand Dollars for that purpose.

(b) A By-Law to inaugurate a Bus System within the City of North Bay and erect a building for the Housing of Municipal, Equipment and Vehicals, and to provide for the borrowing of One Hundred and Ten Thousand Dollars for that purpose.

(c) A By-Law to Purchase the Assets of the North Bay Rink and Auditorium Company Limited and install an artificial Ice Plant and a Heating System in the North Bay Arena and do other necessary improvements thereto, and to provide for the borrowing of Sixty Thousand Dollars for that purpose.

NO THEREFORE THE MUNICIPAL COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

(1) That there shall be submitted to the electors of the Municipal Corporation of the City of North Bay qualified to vote on Money By-Laws the following Proposed By-Laws entitled:

(a) Being a By-Law of the Municipal Corporation of the City of North Bay to provide for the erection of a sewage Disposal Plant in the City of North Bay and to provide for the borrowing of Six Hundred and Fifty Thousand Dollars for that purpose.

(b) Being a By-Law of the Municipal Corporation of the City of North Bay to provide for the purchase of the assets of the North Bay Rink and Auditorium Company Limited and the installation of an Artificial Ice Plant and Heating System and necessary improvements to the Arena Building and to provide for the borrowing of Sixty Thousand Dollars for that purpose. (c) Being a By-Law of the Municipal Corporation of the City of North Bay for the inauguration of a Bus System and the erection of a Garage Building in the City of North Bay and to provide for the borrowing of One Hundred and Ten Thousand Dollars for that purpose.

(2) A Copy of each of the above Proposed By/Laws is attached hereto and Marked Exhibit A, B, C, respectively and forms part of this By-Law.

(3) THAT the votes of the said electors shall be taken on the said By-Laws at the same time and places by the Deputy Returning Officers and Poll Clerks, at the Annual Municipal Elections.

(4) A True Copy of the By-Law shall be published in the North Bay Nugget on the days hereinafter mentioned, that is to say, on the Seventh, Fourteenth and Twenty-First days of November, 1946.

(5) On the 28th day of November at his Office in the Council Chamber, on Ferguson Street, in the City of North Bay at 2 o'clock in the afternoon, the Mayor will in writing signed by him appoint two persons to attend the Final Summing up of the votes by the Clerk of this Corporation, and one person to attend each Polling Place on behalf of the Persons interested in and desirous of promoting the proposed Money By-Laws, and a like number on behalf of the persons interested in and desirous of opposing the proposed money By-Laws.

(6) THE ELEVENTH DAY OF DECEMBER AT THE SAID COUNCIL CHAMBER AT TWELVE O'CLOCK in the Forenoon is hereby appointed as the time and place for summing up, by the Clerk of this Corporation of the number of votes given in the affirmative and in the negative, respectively, FINALLY PASSED AND ENACTED THIS 21st DAY OF OCTOBER, A.D., 1946.
