

**THE CORPORATION OF THE CITY OF NORTH BAY**

**BY-LAW NO. 1999-45**

**BEING A BY-LAW TO AMEND TRAFFIC BY-LAW  
NO. 131-93, SCHEDULE 6 (PARKING PROHIBITED  
FOR RESTRICTED PERIODS); SCHEDULE 10 (STOP SIGNS);  
SCHEDULE 12 (TRUCK ROUTES);  
SCHEDULE 20 (TRAFFIC CONTROL SIGNALS)**

**WHEREAS** the *Municipal Act*, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass By-laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways.

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Schedule 6 to Traffic By-law No. 131-93 is hereby amended by adding the following:

Airport Road and Duxford Street	on all four approaches
Ski Club Road and O'Brien Street	on all four approaches




