AND WHEREAS by selling consumers higher cost energy as well as triggering cancellation fees on existing contracts, consumers are incurring debt which often leads to the disconnection of service;

AND WHEREAS in many cases our social service agencies have had to intervene on behalf of clients causing undue financial stress on our government agencies;

AND WHEREAS there is a need for more aggressive and severe penalties and sanctions applied against offending marketing and retail companies when evidence of unfair marketing practices and/or false advertising is found;

THEREFORE BE IT RESOLVED THAT the City of North Bay supports and endorses MPP David Ramsay's Private Member's Bill to amend the *Ontario Energy Board Act, 1998*, which is a proactive first step to having better controls on these types of retail companies and states:

That retailers of energy and marketers of gas and hydro be required to provide a reaffirmation letter to the consumer that must be signed and returned to the retailer; and

That, the reaffirmation letter, which is the only means by which the consumer may reaffirm the contract, must contain the following information:

- a. the price the consumer would pay under the new contract
- b. any penalties that would be triggered by cancelling the current contract with the retailer
- c. the price the consumer is currently paying
- d. the price the consumer would pay direct from the distributor; and

That if the bill is passed, it would prevent retailers from automatically enrolling consumers into a contract through the cashing of a cheque that was received through direct mail.
