Whereas Northern Ontario already faces challenges with
rising gasoline costs and has colder winters impacting home
heating costs;

And Whereas the Cap and Trade Plan includes a 4.3 cent per litre increase in fuel costs and a potential average provincial monthly increase of \$5 per month for natural gas;

And Whereas that monthly natural gas hike could be much higher in Northern Ontario as we typically have harsher winter weather and a longer cold season;

And Whereas North Bay residents and Northern Ontario residents already face automobile fuel costs challenges, and often face farther driving distances between major centres for health care or other reasons;

And Whereas the new Cap and Trade Proposals include HST being charged on top of any new increases;

And Whereas many will view the HST on this increase as a "tax-on-a-tax".

Therefore Be It Resolved that the Government consider exempting Northern Ontario from the natural gas price hikes under Cap and Trade Proposals.

And Further Be It Resolved that the City of North Bay request that the Government review and consider eliminating this proposed increase of 4.3 cents per litre, at least in Northern Ontario, due to the impact it would have on residential and community members already facing economic challenges.

And Further Be It Resolved that the City of North Bay send this request to Premier Kathleen Wynne, Glen Thibeault, Minister of Energy, Steven Del Duca, Minister of Transportation, MPP Victor Fedeli, Members of the Opposition, neighbouring municipalities, Association of Municipalities of Ontario, Federation of Northern Ontario Municipalities, North Bay & District Chamber of Commerce, Canadore College, Nipissing University, Ontario Chamber of Commerce and the Canadian Taxpayers Federation seeking support.
