BY-LAW NO. 112-77

BEING A BY-LAW TO AMEND BY-LAW NO.83-77 BEING A BY-LAW TO AUTHORIZE THE ISSUE OF A DEBENTURE IN THE AMOUNT OF \$636,616.50 FOR THE REPAYMENT OF A LOAN MADE PURSUANT TO THE PROVISION OF PART VI B OF THE NATIONAL HOUSING ACT.

WHEREAS it is considered necessary to amend By-law No. 83-77. NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. THAT the tenth line of Clause 4 (b) of By-law No.

83-77 be amended by showing By-law No. 1-1-74 as amended by By-law No. 106-77 so that the paragraph will now read as follows:

CLAUSE 4 (B):

" (b) In each year during the currency of the said debenture, there shall be levied and raised by a special rate sufficient therefor over and above all other rates on all the rateable property in the City of North Bay, such yearly amount in lawful money of Canada as may be necessary for such purposes and as requirements for such purposes may from year to year vary, the amount of the instalment of principal and interest payable in that year as set forth in Schedule "A" hereto annexed but no greater amount shall be raised than is required after taking into account receipts from the special rate imposed by By-law No. 101-74 as amended by By-law No. 106-77 upon all the rateable property in the Urban Service Area.

READ A FIRST TIME IN OPEN COUNCIL THIS 12TH DAY OF SEPTEMBER, 1977. READ A SECOND TIME IN OPEN COUNCIL THIS 27TH DAY OF SEPTEMBER, 1977. READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 27TH DAY OF SEPTEMBER, 1977.


