BY-LAW No. 1546 Report By 550

BEING a By-Law to authorize construction of a Sanitary Sewer on O'Brien St. and Rose Avenue.

WHEREAS the owners of property abutting on the east side of O'Brien Street have petitioned the Council to construct a Sanitary Sewer, with all necessary private house connections, said petition being dated, the 3rd day of August, 1948.

THEREFORE, THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

- 1. That an eight inch Sanitary Sewer be constructed on O'Brien Street from the City Limits in a southerly direction to Lorne Avenue, a distance of 353 feet more or less.
- 2. That a twelve inch Sanitary Sewer be constructed on O'Brien Street from the end of the above mentioned sewer at Lorne Ave., in a southerly direction to Rose Avenue a distance of 566 feet more or less.
- 3. That a twelve inch Sanitary Sewer be constructed on Rose Ave. from the O'Brien Street sewer in an easterly direction to McPhail Street, a distance of 360 feet more or less.
- 4. That Private Sanitary Sewer connections be installed to the property line for all those property owners who desire and apply to the City Engineer to have such connections provided.
- 5. That the engineer of the Corporation do forthwith make such plans, profiles and specifications and furnish such information as may be necessary for the making of a contract for the execution of the work.
- 6. That the work shall be carried on and executed under the superintendence and according to the directions of such Engineer.
- 7. That the Mayor and Clerk of the Corporation are authorized to cause a contract for the construction of the work to be made and entered into with some person or persons, firm or corporation, subject to the approval of Council, which may be declared by Resolution.
- 8. That the Treasurer may, subject to the approval of the Council, agree with any Bank or person for temporary advances of money to meet the cost of construction pending the completion of it.
- 9. That the cost of all Sanitary Sewer installations referred to in Clauses One, Two and Three, above, be borne entirely by the property owners on the east side of O'Brien Street and Rose Avenue, whose property is abutting on the work, as a local improvement over a period of /5 years.
- 10. That the cost of sewer connections to private properties be paid for as a local improvement by the property owners concerned over a period of /5 years on the basis of actual cost of such private sewer installations.
- 11. That all previous By-Law in whole or in part as they affect this By-Law are hereby suspended.
