### Items Discussed:

1. Review and approval of August 20, 2015 Minutes of the Special Review Committee – Water Rates.

  - i. Media Campaign to be launched next week;
  - Emails to be sent to all those who have registered on the Water Portal thanking them and encouraging them to promote the portal to others;
  - iii. Website information to be expanded to included conservation tips and the ability to have a quick look at consumption;
  - iv. Open Houses to be held once a week throughout the month of September September 3, 10, 16, 23 and 29 (dates to be advertised);
  - v. Water staff to be accessible to the public;
  - vi. ABCs have been contacted to help promote the Water Portal;
  - vii. Advertising to be placed on City Transit Vehicles;
  - viii. Displays to be placed in City Hall Lobby;
  - ix. Public Works' employees to distribute information to homeowners;
  - x. Public Works' students to drop off information door-to-door;
  - xi. Staff to investigate conservation incentives for 2016; and
  - xii. Update on City's initiatives that will reduce "lost water" (i.e. looping, flushing, blow-offs).

Councillor Maroosis – the Communication Plan is designed to be a positive message to the public. Meters are about fairness (equity) and conservation. The public campaign will include conservation and safety and will encourage the public to use the portal.

Regarding subsidies to homeowners, a local business (Carry-All Builders Supplies Ltd) has offered to run their own campaign to offer low-flush toilets and aerators at cost to the public.
