AND WHEREAS many of the communities approached to act as host communities do not have the facilities or proper human resources to adequately address accommodating large groups of people for extended stays;

THEREFORE THE COUNCIL OF THE CITY OF NORTH BAY petitions both the Federal and Provincial governments to work closely and in a time sensitive manner with affected Aboriginal communities to provide acceptable permanent housing solutions for those flood prone communities;

AND THAT a copy of this resolution be sent to the Honourable Chuck Strahl, Minister of Indian Affairs and Northern Development; the Honourable Michael Bryant, Minister Of Aboriginal Affairs; the Honourable Donna Cansfield, Minister of Natural Resource; the Honourable Rick Bartolucci, Minister of Community Safety and Correctional Services; Mr. Maurice Switzer, Union of Ontario Indians.
