

BY-LAW NO. 1987

BEING A BY-LAW of the Municipal Corporation of the City of North Bay to authorize the establishment of a Department of Industries in conjunction with the municipalities of the Township of Widdifield and the Township of West Ferris.


WHEREAS it is deemed necessary to establish a Department of Industries to take all proper steps from time to time to secure industries for, and aid industries in the area comprising the above mentioned municipalities.


AND WHEREAS after due consideration it is agreed that an agreement should be entered into with the municipalities of the Township of Widdifield and the Township of West Ferris for the said purpose.

NOW THEREFORE THE COUNCIL OF THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-

1. THAT an agreement for the purpose of establishing the "North Bay-Widdifield-West Ferris Department of Industries" be entered into with the municipalities of the Township of Widdifield and the Township of West Ferris.
2. THAT the agreement annexed hereto as Appendix "A" shall form part of this by-law.
3. THAT this by-law shall be effective from the first day of the month following the passing of enabling by-laws by all municipalities of the City of North Bay and the Townships of Widdifield and West Ferris.
4. THAT the withdrawal of any one of the three said municipalities will automatically terminate this agreement, provided that notice of such withdrawal which must become effective at the end of any calendar year, shall be given in writing by the withdrawing municipality to each of the other parties to the agreement not less than three months in advance.
5. THAT the Mayor and the City Manager be authorized to sign the annexed agreement and to attend all meetings, make all appointments and do all things necessary to carry out the purpose of this by-law and the said annexed agreement.

APPENDIX "A" TO BY-LAW NO. 1987

DEPARTMENT OF INDUSTRIES AGREEMENT

THIS AGREEMENT MADE THE DAY OF A. D. 1961.

B E T W E E N:-

THE MUNICIPAL CORPORATION OF THE CITY OF
NORTH BAY
THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF
WIDDIFIELD
THE MUNICIPAL CORPORATION OF THE TOWNSHIP OF
WEST FERRIS

WITNESSETH

THAT whereas the Councils of the above mentioned municipalities deem it expedient that a Department of Industries be established to serve the area comprising the said three municipalities;

AND WHEREAS in accordance with the provisions of Section 411 of the Municipal Act, the said municipalities are prepared to enter into an Agreement for the said purpose;

NOW THEREFORE, in consideration of the premises and the mutual covenants and agreements hereinafter contained, the said three municipalities, jointly and severally have agreed and do hereby agree each With the other as follows:-

1. There shall be established a Department of Industries to take proper steps from time to time to secure new industries for and aid industries in the three municipalities heretofore mentioned and generally to give publicity to the advantages of the area for business and manufacturing purposes:-
2. The name of the Department shall be "North Bay - Widdifield - West Ferris Department of Industries".
3. The Department shall consist of 8 members, appointed as follows:-
 - (a) The Mayor of the City of North Bay, and two elected members of the Council of the City of North Bay, appointed by the City Council from time to time.
 - (b) The Reeves of the Townships of Widdifield and West Ferris or in their absence, a member of Council named by the Reeve to represent him.
 - (c) Three members appointed by the Directors of the North Bay and District Chamber of Commerce.
4. Each of the municipalities agrees to contribute to the Department for each year that this agreement remains in effect a sum arrived at by multiplying the number of the population as shown in its Assessor's report for the previous year by 21 cents. For a portion of a year, the amount so paid shall be proportionate to a full year.
5. All monies so contributed shall be used solely for the purposes set out in paragraph one above and any monies not expended by the said Department before the end of each calendar year, shall then be refunded to the contributing municipalities in the proportion of their respective contributions.
6. The said Department shall not later than March the 1st in each year, submit to each of the said municipalities the Department budget for the then current calendar year and such budget together with any revision or amendment thereof shall require the approval of each and every of the said three municipalities before any of the said municipalities shall be liable to pay its contribution thereto. The Department shall have the authority to employ a Commissioner of Industries to bring to the notice of manufacturers and others the advantages of the area as an industrial, business, education, residential or vacation centre and to do all other things to advance the purposes outlined in paragraph one above.

7. The Department hereby established shall have power to take all suitable steps not inconsistent herewith for the purposes mentioned herein including the passing of by-laws for its own government.

8. This agreement shall become effective the first day of the month after being ratified by all the said municipalities.

9. This agreement shall be terminated at the end of any calendar year by any one of the parties hereto giving to each of the other parties hereto not less than three months notice in writing of its intention to withdraw.
