## BY-LAW NO. 2010-177

## A BY-LAW TO CONFIRM THE NUMBER OF BREAK OPEN TICKET LOCATIONS IN THE CITY OF NORTH BAY

**WHEREAS** the <u>Criminal Code (Canada)</u> provides that the provinces may license certain lottery schemes;

**AND WHEREAS** the Lieutenant Governor in Council of Ontario or such other person or authority who the Lieutenant Governor in Council may specify is authorized under the <u>Criminal Code (Canada)</u> to issue or cause to be issued licences to charitable or religious organizations for the purpose of conducting and managing lottery schemes in Ontario;

**AND WHEREAS** Ontario in Council 1413/08 authorizes the licensing framework for charitable organizations to hold lottery events and sets our the limits of municipal and provincial licensing;

**AND WHEREAS** Ontario in Council 1413/08, section 6, authorizes municipalities to attach terms and conditions to licences permitting eligible organizations to conduct Break Open Ticket lotteries from locations within their own boundaries, provided that the Break Open Ticket lotteries are not conducted and managed in conjunction with another licensed gaming event;

**AND WHEREAS** Section 13 of the Alcohol and Gaming Commission of Ontario's Lottery Licensing Policy Manuel allows for more than one location to be licenced for Break Open Tickets per licenced charity;

**AND WHEREAS** the Council passed Resolution 2010-417 at its Meeting held Monday, June 14, 2010, limiting the number of Break Open Ticket locations permitted to each organization to three (3).

## NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. <u>Definitions</u>:

"Break Open Tickets" means a device which is made of cardboard and which has one (1) or more perforated cover window tabs behind which are winning and nonwinning numbers or symbols that must be revealed by the tearing off of the cover tab."

"Charitable Organization" means a corporation, organization, association or partnership which is created primarily for a charitable object or purpose in Ontario, is operated not for profit, and includes a religious organization.

2. That the number of Break Open Ticket locations permitted to each eligible charitable organization be limited to three (3).
