  - b) the 2010 Water Rates By-Law be presented increasing all water rates by 6.9% effective January 1, 2010;
  - c) the Sanitary Sewer Surcharge remain at 106% of water charges;
  - d) the Water Filtration Capital Surcharge, authorized in clause 3.e) of By-Law No. 2008-248 remain at 10% of the gross water component of water accounts effective January 1, 2010; and
  - e) the net increase on a typical flat rate residential account be 6.9% or \$4.08 per month.

- h) the City shall consult with the development community each year in the 4<sup>th</sup> quarter and prepare a report to the Council outlining the development trends of North Bay and surrounding communities.
