**BY-LAW NO. 2006-94**

**BEING A BY-LAW TO AMEND TRAFFIC & PARKING BY-LAW NO. 2002-001  
SCHEDULE 18 (NO PARKING AREAS AT ANY TIME) AND  
SCHEDULE 20 (NO PARKING AREAS RESTRICTED TIMES)**

**WHEREAS** the *Municipal Act, 2001*, (S.O. 2001, c.25) authorizes the Council to pass By-Laws regulating or prohibiting certain traffic on highways and regulating or prohibiting parking on highways;

**AND WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Chapter H-8, as amended, authorizes the Council to pass By-laws regulating traffic on highways;

**AND WHEREAS** the amendment to Schedule 20 (No Parking Areas Restricted Times) was authorized by Engineering & Works Committee Report No. 1999-11 passed by Council at its Regular Meeting held on Monday, August 30, 1999;

**NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:**

1. That Schedule 18 to Traffic & Parking By-Law No. 2002-001 is hereby amended by deleting the following:

2. That Schedule 20 to Traffic & Parking By-Law No. 2002-001 is hereby amended by adding the following:

	Bourke Street	both	Bloem Street and Durrill Street	8:00 a.m. to 6:00 p.m. Monday to Friday inclusive
	Durrill Street	both	McLaren Street and Bourke Street	8:00 a.m. to 6:00 p.m.

3. That this by-law comes into effect upon being passed.
