

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 140-79

BEING A BY-LAW TO AMEND BY-LAW NO. 1896  
AS AMENDED, BEING A BY-LAW TO REGULATE  
TRAFFIC IN THE CITY OF NORTH BAY.

WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to amend By-law No. 1896 of the Corporation of the City of North Bay.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That Schedule "F" (Parking Prohibited at any time) of By-law No. 1896 be amended by

(i) Adding thereto the following:

2. That Schedule "J" Part "C" of By-law No. 1896 be amended by adding thereto the following:
