### THE CORPORATION OF THE CITY OF NORTH BAY

#### **BY-LAW NO. 147-96**

#### BEING A BY-LAW TO AMEND BY-LAW NO. 173-88 BEING A BY-LAW TO REGULATE PARKING ON MUNICIPAL PARKING LOTS

WHEREAS Section 210(32) of the Municipal Act, R.S.O. 1990, Chapter M-45, as amended, authorizes the Council to pass by-laws for prohibiting the parking of motor vehicles on property owned or occupied by a Municipality or any Local Board thereof without the consent of the Municipality or Local Board as the case may be.

**AND WHEREAS** Section 207(56) of the Municipal Act provides that by-laws may be passed for regulating, supervising and governing the parking of vehicles on land owned or occupied by the Municipality.

## NOW, THEREFORE, THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. Sections l(f), 2, 3, 5, 7, 8 and 10 of By-Law No. 173-88 are hereby repealed and the following Sections l(f), 2, 3, 5, 7, 8 and 10 inserted in lieu thereof:
  - 1.(f) "Parking Meter" or "Pay and Display Machine" means a device which indicates the length of time during which a vehicle may be parked, which has as a part thereof a receptacle for receiving and storing coins, a slot or place in which such coins may be deposited, a timing mechanism to indicate the passage of the interval of time during which the parking is permissible and which displays a signal when said interval of time has elapsed or which produces a ticket to show the time for which parking is permitted and includes a Pay and Display Machine.
- 2. No person shall park a motor vehicle in the Parking Garage, being Parking Lot No. 4 and Parking Lot No. 2 between 8 o'clock in the morning and 6 o'clock in the evening on any day except Sunday:
  - (i) unless the fee set by Schedule "B" hereto is paid by the driver of the motor vehicle;
  - (ii) in no case longer than the maximum authorized time for that parking lot as stipulated by Schedule "B" hereto; and
  - (iii) the fee shall not apply to the first entry of a vehicle each day.
- 3. No person shall park a motor vehicle on Parking Lots No.1, 3, 5, 6 or 7 between the hours of 8 o'clock in the morning and 6 o'clock in the evening on any day except Sunday unless and until there is deposited the appropriate fee and the authorization ticket is posted under the front window of the driver's side of the motor vehicle.
- 5. Every motor vehicle parking in a Parking Lot (except the Parking Garage and Lot #2) shall make use of the pay and display machine and the fee set by Schedule "B" hereto shall be paid by the driver of the vehicle for the use of the parking space for the time permitted by Schedule "B" hereto.

7. (a) The Parking Manager or his authorized delegate is hereby authorized to issue permits and to reserve parking spaces for the purposes of permitting parking in the parking lots described in this by-law and to charge therefore the following sums:

Parking Lot Nos. 1, 2 and 3

\$40 per month

Parking Lot No. 4 (Garage)

- top two levels

\$40 per month

- Inside levels

\$55 per month

Parking Lots 6, 7 and 10

\$30 per month

- (b) No person who does not hold an authorized permit for a reserved parking space shall park a motor vehicle in such reserved parking space.
- 8. The Parking Manager shall designate individual parking spaces in the parking lots and shall erect and maintain pay and display machines for Parking Lots No. 1, 3, 5,6 or 7.
- 10. The Parking Manager is directed to post signs stating the conditions on which a motor vehicle may be parking in a municipal parking lot.
- 11. Schedule "A" to By-law No. 173-88 is hereby deleted and the attached Schedule "A" attached hereto and forming part of this by-law is inserted in lieu thereof.
- 12. Schedule "B" to By-law No. 173-88 is hereby deleted and the attached Schedule "B" attached hereto and forming part of this by-law is inserted in lieu thereof.
- 13. This by-law comes into force and effect October 1, 1996.

ALL AND SINGULAR that certain parcel or tract of land and premises, situate, lying and being in the City of North Bay in the District of Nipissing and Province of Ontario and being composed of:

PARKING LOT NO. 1 (OAK STREET EAST) - Part of Lot 20, Concession D, in the City of North Bay, designated as Part 1, Plan 36R-5206, and Part 1, Plan 36R-7499.

PARKING LOT NO. 2 (OAK STREET WEST) - Part of Lot 20, Concession D, in the City of North Bay designated as Parts 5 and 6, Plan 36R-5206, and Parts of Lots 174, 175, 176, 177, 178 and 179, Plan 38, in the City of North Bay, designated as Part 2, Plan 36R-5206, and Part of Toronto Street, Plan 38 in the City of North Bay, designated as Parts 3, 4 and 7, Plan 36R-5206.

PARKING LOT NO. 3 - (MCINTYRE STREET) - On the south side of McIntyre Street East and including Lots 137, 138, 139, the east one half of Lot 92, Lot 140 and the north one half of Lot 141, all according to Registered Plan No. 10 in the City of North Bay.

PARKING LOT NO. 4 (PARKING GARAGE) - On the south side of McIntyre Street West and including Lots 129, 128, the east half of Lot 127, and that part of Lot 127 leased from Walker's Division for 99 years, all according to registered Plan No. 10, in the City of North Bay.

PARKING LOT NO. 5 - On the south side of the 500 block of Main Street West and composed of Part Lot 3, Plan 13 and Part Lot 3, Plan 13 designated as Part 1, Plan 36R-9049.

PARKING LOT NO. 6 (OLD PARKING AUTHORITY LOT) - On the north side of Worthington Street West including Lots 377, 378, the south one half of Lot 429 and the south one half of Lot 430, all according to Registered Plan No. 21 for the City of North Bay having an approximate area of one hundred and thirty-two (132) feet by one hundred and fifty (150) feet.

PARKING LOT NO. 7 - (OLD SCHOOL BOARD LOT) On the east side of Worthington Street East and composed of the west one half of Lot 368, Lots 369, 370, 419, 420, 421 and 422, all according to Registered Plan No. 21 for the City of North Bay.

PARKING LOT NO. 8 (CITY HALL) On the South side of Wyld Street and including all of Lots 277 and 278 according to Registered Plan No. 10 for the City of North Bay.
