

THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 20-92

BEING A BY-LAW TO RENAME THE STREETS  
AND ROADS WITHIN THE CITY OF NORTH  
BAY.

WHEREAS Council may name streets within the City of North Bay pursuant to Section 210 (105) of the Municipal Act;

AND WHEREAS it is deemed desirable to assign or change the names of several streets and roads in the City of North Bay;

AND WHEREAS before passage of this By-Law, notice of same was published at least once a week for four (4) successive weeks in a newspaper having general circulation in the City of North Bay;

AND WHEREAS before passage of this By-Law the Council of the City of North Bay shall hear any person who claims that he will be adversely affected by the By-Law and who applies to be heard.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1) The name of the existing portions of McKeown Avenue from Champlain Street to Algonquin Avenue be renamed Champlain Street.
- 2) The name of Lillian Boulevard be changed to Morel Boulevard.
- 3) The northerly portion of Gormanville Road north of Cedar Heights Road be renamed Larocque Road.
- 4) The existing Larocque Street north of Cedar Heights Road be renamed Leger Street.
- 5) That Gormanville Road from College Drive to Precious Blood Monastery be renamed Monastery Road.
- 6) That the easterly portion of Widdifield Station Road be renamed Laughrin Road.
- 7) That Lamarche Road be renamed Cochrane Road.
- 8) That "B" Line Road east of Highway No. 11 be renamed Cedar Heights Road.
- 9) This By-Law comes into force and effect upon registration of a copy of this By-Law, certified under the hand of the Clerk and the seal of The Corporation of the City of North Bay in the Land Registry Office for the District of Nipissing.

READ A SECOND TIME IN OPEN COUNCIL THIS 3RD DAY OF FEBRUARY 1992.
