THE CORPORATION OF THE CITY OF NORTH BAY

BY-LAW NO. 1-73

BEING A BY-LAW FOR THE PURPOSE OF AMENDING BY-LAW NO. 907, BEING A BY-LAW TO REGULATE THE USE OF LAND AND THE CHARACTER, LOCATION AND USE OF BUILDINGS AND STRUCTURES IN THE FORMER TOWNSHIP OF WEST FERRIS (NOW THE CITY OF NORTH BAY), UNDER THE AUTHORITY OF SECTION 35 OF THE PLANNING ACT, R.S.O. 1970, AND AMENDMENTS THERETO.

WHEREAS the Council of The Corporation of the City of North Bay, with the approval of the Planning Board, deems it advisable to amend By-law No. 907, of the former Township of West Ferris, to provide for an alteration in the Definitions and Parking Requirements as set forth in Sections 2 and 3.18 respectively.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That Section 2 "Definitions" be amended as follows:
 - (a) Add Section 2.21 (i) Efficiency Unit: Means a part of a hotel which contains sleeping facilities, private sanitary facilities and cooking facilities which are located in not more than two rooms, excluding the washroom.
 - (b) Amend Section 229 to read as follows:

Hotel: Means a separate building or two or more connected buildings used primarily for the purpose of catering to the needs of the travelling public by the supply of food and refreshment from a general kitchen, dining room and other public rooms, and also by the furnishing of sleeping accommodation of not fewer than six bedrooms.

Section 229 (i) it is further provided that not more than twenty-five per cent (25%) of the rentable units in a hotel may be efficiency units.

(c) Amend Section 2.39 to read as follows:

Motel: Means a separate building or two or more connected buildings used primarily for the purpose of the public travelling by motor vehicle by furnishing sleeping accommodation with or without supplying food in a building which does not exceed two stories in height.

2. That Section 3.18 "Parking Requirements" be amended as follows:

TYPE OF BUILDING

Hotels and Motels

PARKING REQUIRED

One (1) parking space for each guest room or suite, plus one (1) parking space for each one hundred square feet (100 sq.ft.) of floor area of the building devoted to public uses. 3.




