THE CORPORATION OF THE CITY OF NORTH BAY BY-LAW NO. 21-72

BEING A BY-LAW TO ESTABLISH AN AREA FOR THE COLLECTION, REMOVAL AND DISPOSAL OF GARBAGE

WHEREAS The Municipal Act, R.S.O. 1970, Chapter 284, Section 354 (1) 78 authorizes a Council of a local municipality to pass by-laws for the collection, removal and disposal of garbage and other refuse in a defined area of the municipality.

AND WHEREAS the Council of the Corporation of the City of North Bay deems it advisable to enact a by-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. The garbage collection area for the City of North
 Bay is hereby established in accordance with
 Schedule "A" attached hereto and forming part of
 this By-law.
- By-law No. 754 of the Township of West Ferris and By-laws Nos. 847 and 866 of the Township of Widdifield are hereby repealed.

THIS IS SCHEDULE "A" TO BY-LAW NO. 21-72 OF THE CORPORATION OF THE CITY OF NORTH BAY

Commencing at a point where the southeasterly corner of Lot 25, Concession 11 intersects the boundary between the City of North Bay and the Township of North Himsworth;

Thence in a generally southwesterly direction along the boundary between the City of North Bay and the Township of North Himsworth to a point where the said boundary intersects the shoreline of Lake Nipissing;

Thence in a generally northwesterly direction along the shoreline of Lake Nipissing to a point where the shoreline of Lake Nipissing intersects the boundary between the City of North Bay and the Township of Commanda;

Thence northerly along the boundary between the City of North Bay and the Township of Commanda to a point 150 feet north of the line between Concessions A and B;

Thence easterly in a straight line and parallel to the line between Concessions A and B to a point where the line intersects the line between Lots 21 and 22, Concession A;

Thence northerly along the line between Lots 21 and 22 to a point 150 feet north of the line between Concessions 3 and 4;

Thence westerly in a straight line and parallel to the line between Concession 3 and 4 to a point where the line intersects the line between Lots 17 and 18, Concession 4;

Thence southerly along the line between Lots 17 and 18 to the line between Concessions A and 1;

Thence easterly along the line between Concessions A and 1 to a point where the line intersects the line between Lots 16 and 17;

Thence southerly along the line between Lots 16 and 17 to the line between Concessions A and B;

Thence easterly along the line between Concessions A and B to the line between Lots 13 and 14;

Thence southerly along the line between Lots 13 and 14 to a point 500 feet north of the line between Concessions B and C;

Thence easterly in a straight line and parallel to the line between Concessions B and C to the line between Lots 9 and 10;

Thence southerly along the line between Lots 9 and 10 to a point where the line between Lots 9 and 10 intersects the shoreline of Lounsbury Bay;

Thence in a generally south southwesterly direction and following the sinuosities of the shoreline of Trout Lake to a point where the said shoreline intersects the boundary between the City of North Bay and the Township of East Ferris;

Thence southeasterly along the said boundary between the City of North Bay and the Township of East Ferris to the point of commencement.
