BY-LAW NO. 2030

A BY-LAW to amend By-law No. 1941, being a by-law to provide for the construction of sanitary sewers, and the necessary drain connections thereto, on certainsstreets and to provide for imposing upon owners of land who derive, or will, or may derive a benefit from such sanitary sewers, a sewer rate sufficient to pay for the whole capital cost of such sanitary sewers.

WHEREAS it is deemed expedient to amend said by-law No. 1941 to provide that the interest charges on debentures to be issued shall be included in the Corporation's cost of the works and

WHEREAS it is deemed desirable to add such owner's frontage charges to the tax roll and to levy and collect such charges in a like manner and at the same time as Municipal taxes in lieu of rendering such charges semi-annually and inclusively with the water accounts

NOW THEREFORE THE MUNICIPAL CORPORATION OF THE CITY OF NORTH BAY under the provisions of the Municipal Act, R.S.O. 1950, Chap. 243, Sec. 389, S.S. 2 as re-enacted by Chap. 249, Section 380, S.S. 2 R.S.O. 1960 ENACTS AS FOLLOWS:-

- 1. THAT Clause No. 2 be amended by deleting therefrom the words "interest and" immediately following the words "the payment of" and immediately preceding the word "principal" and that line No. 10 be amended by deleting therefrom the amount of .82¢ (eithty-two cents) and inserting therein the amount of .47¢ (forty-seven cents).
- 2. THAT Clause No. 3 be deleted in its entirely and the following added in lieu thereof -

THAT the sewer rate imposed in Clause No. 2 above shall be added to the collector's roll and collected in a like manner and at the same time as Municipal taxes as prescribed from time to time by by-law governing the collection of Municipal taxes.

3. THAT this By-law shall not become effective until approval in writing has been secured from the Ontario Municipal Board pursuant to Section 380(2) of the Municipal Act (R.S.O. 1960, Chap. 249).


