## THE CORPORATION OF THE CITY OF NORTH BAY

## BY-LAW NO. 113-69

BEING A BY-LAW TO CLOSE AND STOP UP PART OF AN EXISTING HIGHWAY KNOWN AS GOLF STREET BEING PART OF LOTS 316 AND 317 AS SHOWN ON PLAN 10, REGISTERED IN THE REGISTRY OFFICE FOR THE REGISTRY DIVISION OF THE DISTRICT OF NIPISSING AT NORTH BAY.

WHEREAS it is deemed expedient in the interest of The Corporation of the City of North Bay, that part of the existing highway known as Golf Street set out and described in Schedule "A" attached hereto be closed and stopped up.

AND WHEREAS notice of this By-law was published once a week for four consecutive weeks in the North Bay Nugget, published in the City of North Bay.

AND WHEREAS Registered Plan of Subdivision Number 10 was registered prior to the 27th day of March, 1946 and approval of the Minister of Municipal Affairs was not required by virtue of Section 459 Sub-Section 8 of The Municipal Act as amended.

AND WHEREAS no person by himself, or by his Counsel,, Solicitor or Agent acting on his behalf appeared to be heard to claim that his, her or their lands would be prejudicially affected by the passing of this By-law.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

- 1. That upon and after the passing of this By-law that part of the existing highway known as Golf Street set out and described in Schedule "A" attached hereto, be and the same is hereby closed and stopped up and after the same has been registered in the name of the Corporation of the City of North Bay it shall be transferred to the Ontario Northland Transportation Commission.
- 2. That this By-law shall take effect forthwith upon the passing thereof.

READ A FIRST TIME IN OPEN COUNCIL THIS 10th DAY OF DECEMBER, 1969.

READ A SECOND TIME IN OPEN COUNCIL THIS 10th DAY OF DECEMBER, 1969.

READ A THIRD TIME IN OPEN COUNCIL AND FINALLY ENACTED AND PASSED THIS 26TH DAY OF JANUARY, 1970.

## SCHEDULE "A"

In the City of North Bay, in the District of Nipissing, and being part of Lots 316 and 317, as shown on Plan 10 registered in the Registry Office for the Registry Division of the District of Nipissing and designated as Parts 1 and 2 on a plan of survey of record in the Registry Office at North Bay as NRD-2011. Said Parts 1 and 2 on Plan NRD-2011 are part of a public highway known as Golf Street which has been in existence and used by the public, in the City of North Bay for a period of at least sixty years.
