

BY-LAW NO. 1287

A By-LAW to levy the Taxes for the year 1938 and to provide for the Collection thereof.

WHEREAS it is necessary and expedient to levy on the whole rateable property, according to the last revised Assessment Roll of the City of North Bay, a sum of money for the general purposes of the City for the current year, and for the purpose of defraying part of the expenses of Public, Separate, Collegiate and Vocational School education, Public Library, Direct Relief and other purposes.

THEREFORE the Council of the Municipal Corporation of the City of North Bay enacts as follows:

1. FOR the purpose of providing the sum of \$597,917.00 for the general purposes of the Corporation, including the amount required for Public, Separate, Collegiate and Vocational Schools, Public Library, Direct Relief and other purposes for the current year, there shall be levied and collected a rate of 62 Mills in the dollar upon the whole rateable property of the Public School Supporters of the City of North Bay according to the last revised Assessment Roll, which rate is made up as follows:

General Rate .....	34.5 Mills
being 35.5 Mills less 1 Mill deduction as provided by the Ontario Government Subsidy	
Collegiate & Vocational School Rate .....	9. Mills
Public School Rate .....	14.5 Mills
Direct Relief .....	4. Mills

and there shall be levied and collected during the said year a rate of 68 Mills in the dollar upon the whole rateable property of the Separate School Supporters of the City of North Bay, according to the last revised Assessment Roll, which rate is made up as follows:

General Rate .....	34.5 Mills
being 35.5 Mills less 1 Mill deduction as provided by the Ontario Government Subsidy	
Collegiate & Vocational School Rate.....	9. Mills
Separate School Rate.....	20.5 Mills
Direct Relief .....	4. Mills

2. AND it is hereby enacted that all taxes shall be paid into the Office of the Treasurer or the Collector of the City of North Bay.

3. THE Taxes shall be payable in six instalments. One instalment of twenty-five (25%) per cent shall be payable on the 16th. day of May, 1938; 15% on the 15th. day of June, 1938; 15% on the 15th. day of July, 1938; 15% on the 15th. day of August, 1938; 15% on the 15th. day of September, 1938 and 15% on the 15th. day of October, 1938.

4. A discount of 4% per annum up to the payment date will be allowed on any instalment of taxes other than the first instalment, including local improvements, paid in advance of the payment date thereof with any previous instalment. Any instalment payments made subsequent to any payment date will be calculated as of the next following payment date.

5. AN addition of four percent shall be made to every tax or assessment remaining unpaid after any date herein fixed for payment thereof, and being the actual amount of same then in default, provided, however, that if any of such taxes are paid within the dates specified below after the date herein fixed for the payment thereof, the following percentages only shall be charged and payable thereon, namely:-

Taxes payable on the 16th. day of May, 1938, if paid after the 20th. day of May, 1938, but on or before the 3rd. day of June, 1938, 1%:

- If paid on or before the 4th. day of July, 1938, 2%:
- If paid on or before the 3rd. day of August, 1938, 3%:
- If paid on or before the 3rd. day of September, 1938, 4%:
- If paid thereafter, 4%.

Taxes payable on the 15th. day of June, 1938, if paid after the 18th. day of June, 1938, but on or before the 4th. day of July, 1938, 1%:

- If paid on or before the 3rd. day of August, 1938, 2%:
- If paid on or before the 3rd. day of September, 1938, 3%:
- If paid on or before the 3rd. day of October, 1938, 4%:
- If paid thereafter, 4%.

Taxes payable on the 15th. day of July, 1938, if paid after the 18th. day of July, 1938, but on or before the 3rd. day of August, 1938, 1%:

- If paid on or before the 3rd. day of September, 1938, 2%:
- If paid on or before the 3rd. day of October, 1938, 3%:
- If paid on or before the 3rd. day of November, 1938, 4%:
- If paid thereafter, 4%.

Taxes payable on the 15th. day of August, 1938, if paid after the 18th. day of August, 1938, but on or before the 3rd. day of September, 1938, 1%:

- If paid on or before the 3rd. day of October, 1938, 2%:
- If paid on or before the 3rd. day of November, 1938, 3%:
- If paid on or before the 3rd. day of December, 1938, 4%:
- If paid thereafter, 4%.

Taxes payable on the 15th. day of September, 1938, if paid after the 19th. day of September, 1938, but on or before the 3rd. day of October, 1938, 1%:

- If paid on or before the 3rd. day of November, 1938, 2%:
- If paid on or before the 3rd. day of December, 1938, 3%:
- If paid thereafter, 4%:

Taxes payable on the 15th. day of October, 1938, if paid after the 19th. day of October, 1938, but on or before the 3rd. day of November, 1938, 1%:

- If paid on or before the 3rd. day of December, 1938, 2%:
- If paid thereafter, 4%:

6. IN default of payment of any instalment of taxes or any part of any instalment by the day named herein for the payment thereof, the subsequent instalment or instalments shall forthwith become payable.

7. THE Collector's Rolls for the year 1938, shall be returned by the Tax Collector to the City Treasurer under the provisions of the Statutes in that behalf.

8. NOTHING herein done shall prevent the Tax Collector from proceeding at any time with the collection of any rate, tax or assessment, or any part thereof in accordance with the provisions of the Statutes and By-Laws governing the Collection of Taxes.

9. THE Collector of Taxes may mail or cause to be mailed to the address of the residence or place of business of each person taxed, the notice specifying the amount of taxes and local improvements rates payable by such person.
