

The Corporation of the City of North Bay

By-Law No. 2016-04

Being a By-Law to Provide for the Remuneration of the Mayor and Councillors of the City of North Bay and to Repeal By-Law No. 2000-146, as amended.

Whereas General Government Committee Report No. 2015-25 passed by Council at its Regular Meeting held on Monday, December 14, 2015 Council approved a new salary schedule for the Mayor and Councillors;

And Whereas Section 283 of the *Municipal Act* 2001, S.O. 2001, as amended, is intended to authorize Council to pay remuneration and expenses to members of Council.

Now Therefore the Council of The Corporation of the City of North Bay hereby enacts as follows:

1. (a) That each Councillor of The Corporation of the City of North Bay be paid an annual allowance of \$23,691.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties as a member of the Council.
- (b) That the Deputy Mayor of The Corporation of the City of North Bay be paid an annual allowance of \$26,956.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties as a member of the Council.
- (c) That the Mayor of The Corporation of the City of North Bay be paid an annual allowance of \$65,157.00 per annum, of which one-third shall be deemed to be for expenses incident to the discharge of his/her duties as a member of the Council.
2. Councillors be provided with payment in lieu of benefits at a rate of 8% of their annual remuneration effective January 1, 2017.
3. That the Mayor and Councillors appointed to Agencies, Boards or Commissions where other Municipal representatives or Provincial appointees receive a stipend for attending meetings be directed to accept the remuneration and direct that it be payable to the City of North Bay on their behalf.
4. The City Treasurer is authorized to adjust the annual allowances referred to in paragraph 1 on January 1 of each year, on an annual basis, commencing January 1, 2017, based on the annual change in the Canadian Consumer Price Index for November 1, 2016 from November 1, 2015 and continuing as of November 1 of the previous year for each year thereafter.
5. That the allowances herein set out shall be paid monthly, not in advance.
6. That this By-law shall come into force as of the 1st day of January, 2016.

7. That By-Law No. 2000-146, as amended, of The Corporation of the City of North Bay is hereby repealed.
