BEING A BY-LAW of the Municipal Corporation of the City of North Bay to close certain lanes and streets in the City of North Bay, and being composed of parts of certain lanes and part of McGaughey Avenue, and which parcels or tracts of land may be more particularly described as follows:-

WHEREAS The Municipal Council of the Corporation of the City of North Bay have been requested, and upon consideration, deem it advisable to close a portion of a street in the City of North Bay and parts of lanes, said portion of street being composed of part of McGaughey Avenue and said lanes being certain lanes in the City of North Bay.

THEREFORE under and by virtue of the authority vested in the Council of the Municipal Corporation of the City of North Bay by the Municipal Act, being R.S.O. 1950, Chapter 243, THE COUNCIL OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the City of North Bay in the District of Nipissing and being composed of parts of certain lanes and part of Mc-Gaughey Avenue, and which parcels or tracts of land may be more particularly described as follows:-

FIRSTLY: Part of registered plan No. 57 being a lane lying adjacent to and immediately to the south of Lots 473 and 474 as the said lots are shown on a plan of sub-division registered in the Registry Office for the Registry division of the District of Nipissing, as Plan No. 57, <u>IS HEREBY</u> <u>CLOSED AND STOPPED UP</u>.

SECONDLY: Part of registered plan No. 93 being a lane lying adjacent to and immediately to the south of Lots No. 10 according to a plan of subdivision registered in the Registry Office for the Registry Division of the District of Nipissing, as Plan No. 93, <u>IS HEREBY CLOSED AND STOPPED</u> <u>UP</u>.

THIRDLY: Part of McGaughey Avenue, registered plan M.189 being all that portion of McGaughey Avenue, extending from its intersection with the south limit of Cassells Street southerly to its intersection with the north limit of Fraser Street, as shown on a plan of sub-division registered in the Land Titles Office at North Bay, as Plan M.189, <u>IS HEREBY</u> <u>CLOSED AND STOPPED UP</u>.

FOURTHLY: Part of registered plan M.189, being a lane lying adjacent to and immediately to the east of Lot 42 to 55 and also lying adjacent to and immediately to the west of lot 106 to 119 as the said lots are shown on a plan of sub-division registered in the Land Titles Office at North Bay, as Plan M.189, IS HEREBY CLOSED AND STOPPED UP.

The said lanes and portion of McGaughey Avenue being further shown outlined in red on a plan of survey dated January 13th 1954, and signed by M. N. Simpson, Ontario Land Surveyor.

THAT the Council of the Municipal Corporation in the City of North Bay shall hear in person or by his or her solicitor, counsel or agent, any person who claims that his or her lands will be prejudicially affected by this by-law and who applies to be heard.

THAT this By-law shall take effect upon the passing thereof and after notice of the same has been published once a week for four consecutive weeks as provided by the Statutes in that behalf.

READ A FIRST TIME IN OPEN COUNCIL THIS 7TH DAY OF FEBRUARY 1955. READ A SECOND TIME IN OPEN COUNCIL THIS 7TH DAY OF FEBRUARY 1955. RULES OF ORDER WERE SUSPENDED AND BY-LAW READ A THIRD TIME SHORT AND PASSED THIS 7TH DAY OF FEBRUARY 1955.
