BY-LAW NO. 2337

Being a By-law to expropriate an easement to construct, install and maintain a storm sewer under the easterly ten feet from front to rear of Lot 17 as shown on Registered Plan 76 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing.

WHEREAS it is necessary to construct, install and maintain a storm sewer under the land hereinafter more particularly described;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

1. That an easement to construct, install and maintain a storm sewer under the land hereinafter more particularly described be expropriated and taken for or in connection with the purposes hereinbefore recited.

DESCRIPTION OF LAND

The easterly ten feet from front to rear of Lot 17 as shown on Registered Plan No. 76 for the City of North Bay registered in the Registry Office for the Registry Division of the District of Nipissing and which may be more particularly described as follows:

PREMISING that the bearings herein are assumed and are derived from the Northerly limit of Hammond Street as shown on Registered Plan No. 76, having an astronomic course of North 58 degrees, 32 minutes East and relating all bearings herein thereto:

COMMENCING at an iron bar planted at the South Easterly angle of Lot 17;
THENCE North 31 degrees, 27 minutes West along the Easterly limit of said Lot 17, a distance of 132.00 feet to an iron bar planted at the North Easterly angle of said lot;
THENCE South 58 degrees, 32 minutes West along the Northerly limit of Lot 17 a distance of 10.00 feet to an iron bar;
THENCE South 31 degrees, 27 minutes East and parallel to the Easterly limit of Lot 17 a distance of 132.00 feet more or less to an iron bar planted in the Southerly limit of said Lot 17 being also the Northerly limit of Hammond Street, and distant 10.00 feet measured South 58 degrees, 32 minutes West from the Point of Commencement;
THENCE North 58 degrees, 32 minutes East along the Northerly limit of Hammond Street 10.00 feet to the Point of Commencement.
