

BY-LAW NO. 1195.

BEING A BY-LAW to modify the salaries of the officials and employees of the Corporation of the City of North Bay.

WHEREAS it is deemed advisable to change the salaries of some of the officials and employees of the City of North Bay.

THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:-


1. That the salaries of the various officials and employees of the City of North Bay be changed in accordance with Schedule "A" which is attached hereto and made part of this By-Law.

2. That those parts of By-Laws Numbers 741, 843, 884, 888, 889, 897, 941, 942, 944, 1044, 1066, 1101, 1109, 1141, 1144, 1145, 1146, 1148, 1154, 1159, 1174 and any other By-Laws or parts thereof inconsistent with this By-Law be and the same are hereby repealed.
