

BEING A BY-LAW to amend By-Laws No. 1438 and 1441 which are By-Laws to provide for the Cleaning of Streets of the City of North Bay, and for Collection of Waste.

WHEREAS it is deemed advisable to amend By-Laws No. 1438 and 1441.

THEREFORE THE MUNICIPAL COUNCIL OF THE MUNICIPALITY OF THE CITY OF NORTH BAY ENACTS AS FOLLOWS:

(1) That By-Law 1438 be amended as follows;

CLAUSES "1-A", 1-B, and 2-A", be deleted and the following be placed in lieu thereof;

"(1-A)" "Garbage" shall mean all rejected abandoned or discarded household waste either animal or vegetable, wearing apparel, sweepings, including all matter capable of consumption by Fire, and Tins, Bottles, Metals, Crockery, Glass, but not "ashes"; and in case of any Hotel, Restaurant or Apartment House with Restaurant in connection requiring more than two collections of Garbage a week "Garbage" shall mean table and kitchen waste consisting of animal and vegetable matter only with which no other waste product or material shall be mixed.

"(1-B)" "Ashes" shall mean the residue of any household fuel after such has been consumed by fire.

"(2-A)" The Sanitation Department and all equipment used by that Department shall be under the charge of the City Engineer, and if the Corporation has no permanent Engineer employed then under the charge of the City Foreman.

CLAUSE "8" second paragraph be deleted, and the following paragraph placed in lieu thereof.

Such receptacles shall be kept on a portion of the premises of or connected with the dwelling of the householder and on the day of collection shall be placed on City Property facing the street, and must be put out not later than 8 A.M. on said day of collection, and it shall be unlawful for any person to place any waste paper, garbage or ash receptacle upon or in any street except as provided in this paragraph, when all such materials shall be contained in proper covered receptacles as defined by Section 5, of By-Law No. 1438, except waste paper which shall be securely tied in bundles.

CLAUSES 15 and 16 are hereby repealed.

CLAUSE 21 be hereby deleted, and the following placed in lieu thereof.

The disposal of Garbage by burning in open air incinerators or on the ground is hereby prohibited.

(2) That By-Law No. 1441 be amended as follows;

That the word "two" after the words "not more than" in Clause 1 of By-Law No. 1441 be changed to read "Three".

(3) This By-Law shall take effect on the passing thereof.
