CORPORATION OF THE CITY OF NORTH BAY BY-LAW NO. 2282

Being a By-law passed pursuant to the provisions of the Local Improvement Act, R.S.O. 1960, Chapter 223, Section 8, declaring it is desirable that the construction of concrete sidewalks, as described in Schedule "A", and replacement concrete sidewalks as described in Schedule "B" to this by-law should be undertaken as a local improvement.

THE COUNCIL OF THE CORPORATION OF THE CITY OF NORTH BAY HEREBY ENACTS AS FOLLOWS:

Pursuant to the provisions of The Local Improvement Act, R.S.O. 1960, Chapter 223, Section 8, it is hereby declared it is desirable that the construction of the concrete sidewalks and replacement concrete sidewalks on certain streets in the City of North Bay as specified and described in Schedules "A" and "B" attached (and which said Schedules "A" and "B" shall be deemed to be incorporated in and form a part of this By-law) should be undertaken as a local improvement.
